HEADSTRONG is an evidence-based anti-stigma initiative created by the Mental Health Commission of



Canada (MHCC). It inspires youth ages 12-18 to Be Brave, Reach Out and Speak Up about mental health. This national initiative teaches students how to reduce stigma and become mental health champions in their schools.

"A team from each high school in the Annapolis Valley Regional Centre for Education (AVRCE) attended a HEADSTRONG summit at Camp Brigadoon in October. Those teams are starting inschool HEADSTRONG committees with other interested students and the support of school staff. Students use their own creativity and the HEADSTRONG School-Based Activity Toolkit to hold awareness and education activities for the whole school," said Mike Ouellette, AVRCE Supervisor of School

Support Services. "Valley Credit Union's donation will go a long way in assisting these student-led teams in their work."

"Mental health is a serious concern for many people and while we are getting better at talking about it we still have a long way to go. The HEADSTRONG program is all about removing the stigma around mental health issues so that students feel safe, supported, and more likely to seek out assistance when they need it," said Len Ells, Valley Credit Union's President and CEO. "We are excited about what these students are creating in their schools and we hope
